**Old Business:**

- Flight Time Cap
  - Expense in maintenance due to excessive flight hours.
  - Fuel approval by Sheriff \$5,000.00
    - Current fuel cost through August \$23,814.13.
- New Aircraft
  - Funds put aside for aero squadron.
    - Approved by county 3 years ago.
    - Funds from Rural Area Taskforce.
  - County will purchase aircraft through a booker.
    - A list of desirable brokers will be forwarded to the county by the Commander.
  - Aircraft Insurance
    - The County will self insure.
  - Cessna 172 vs. 182, approximately a 45-48% difference in operations cost.
    - Increased cost not practical to our budget.
  - G-1000 vs. Conventional Instruments.
    - G-1000 not practical for our operations.
  - Maintenance
    - Squadron forgoes \$10,000 donation vs. receiving the funds.
      - Squadron receiving the funds is preferred.
      - Squadron can control maintenance operations.
- Selling 1V1 (87M)
  - Funds will be used toward Aircraft operations (Engine Replacement)
- Meeting at Nor-Cal tentatively set for February 2011.
